



Exchange Cooperation

1. Overseas Internship (maximum 5 students)

(1). Internship

Both faculty and college shall arrange the legal university industry partners for the intern students during the time of internship studies. The faculty and college shall train and send qualified intern students. The intern qualifications shall meet the needs of university industry partners in general. Specific intern qualification shall be discussed otherwise.

(2). Accommodation:

Both faculty and college shall arrange the accommodation for the intern students during the time of internship studies. Unless otherwise specified, students shall be responsible for the expenses.

(3). Training Courses:

Allow the intern students to take the courses in the faculty and college, as part of the internship program. Unless otherwise specified, the tuition shall be waived. The specific course design shall be discussed otherwise.

(4). Internship Certificate:

Provide an internship certificate with specified internship studies hours upon successful completion of the program.

(5). Salary:

Unless specified otherwise, following government labor regulation (foreigner) and immigration law (visa), the intern positions, by law, are non-paid positions. The work benefits shall be discussed otherwise with industry partners.

2. Exchange Program (maximum 5 students/semester)

- (1). At College of Management, NCUT:
 - 1. Time: during academic semester and semester break
 - ◆ Fall semester: Mid-September Mid-January
 - ◆ Spring semester: End of February Mid-June
 - 2. Courses: Tuition fee shall be waived.
 - 3. Travel/Accommodation/Activities: unless specified otherwise, students shall be responsible for the necessary expenses.
 - 4. Certificate: NCUT will provide
 - 5. Invitation letter: NCUT will provide.
- (2). At Faculty of Management Sciences, CMRU:
 - 1. Time: during academic semester and semester break
 - ◆ First semester: Mid-June Mid-October
 - ◆ Second semester: End of October End of February
 - ◆ Summer semester: March May
 - 2. Courses: Tuition fee shall be waived.
 - 3. Travel/ Accommodation/Activities: unless specified otherwise, students shall be responsible for the necessary expenses.
 - 4. Certificate: CMRU will provide.
 - 5. Invitation letter: CMRU will provide.

3. Visiting Scholar (maximum 2 faculty members/semester)

- 1. Travel/Accommodation: unless specified otherwise, faculty members shall be responsible for the necessary expenses.
- 2. Both college and faculty shall arrange special lecture in the academic programs (lecturer fee will provide depending on the budget).

3. Both college and faculty will encourage faculty members for research or academic collaboration.

Note: This plan shall be effective for (3) three years from the date of final signature. This plan is subjected to review, revision, modification, or renewal by mutual written agreement. Either party may terminate the agreement by written notice submitted before the end of March each year. Termination would not affect students who already engaged in the agreement.
